Subject:- Sixth Five Year Plan(1980-85)-Expansion of Educational facilities at the High Stage-
Upgradation of Senior Basic Schools during 1982-83

In continuation to this Directorate's Memo of even number dated 18.1.83 on the subject stated above, it is stated that it has further been decided to upgrade the Darchawi Christian Jr. High School (private aided) to Class-X High School in Kailashahar Block, Pabnapherra Mouza, North District, with effect from the academic session 1983.

CONDITIONS :

- a) Donation of 15(fifteen) kanis of land (inclusive of the land under actual and valid possession of school by a deed of gift in the name of Education Department, Tripura.
- b) Construction of additional school building measuring 60'x20' plus 5' Verandah divided into three Class-rooms measuring 20'x20' each with Sal or Kral wood posts, wooden doors, windows and windows are with tarpaulin roofing. In case GCI sheets are not available, bamboo single roofing or 9" grass roofing.

The above terms and conditions are however relaxed as a Special Case.

In all matters relating to the starting of schools correspondence may be made with the Planning Section of the Directorate.

Subject:- Recognition of Dorchawi Christian Junior High School alongwith its attached primary Section, P.O. Kumarghat, North Tripura.

Dorchawi Christian Junior High School alongwith its attached primary section (English medium), P.O. Kumarghat, North Tripura is recognised G.O.F. 1.1.80 for one year and the same brought under Grant-in-aid list G.O.F. 1.1.80 subject to on fulfilment of the following terms and conditions:-

1. Classes shall be opened with one section for each class. Opening of new section/class shall require prior approval of the Directorate of School Education.
2. The school shall follow the syllabus of "Shishu Bihar - School" Agartala.
3. The Managing Committee shall appoint duly qualified teacher(s). The teacher-pupil ratio for calculating number of teachers admissible shall be as follows:-
Primary Section (from classes I to V) 1 : 40 students
Middle/Secondary Section (from classes VI to VIII) 1 : 20 students.

The Head of the Institution shall be a trained person. The scale of pay and other admissible allowances and the qualification of teachers in the school will be the same as applicable to the teachers in Government schools in Tripura.

4. The school shall follow the Grant-in-aid Rules in Tripura (Copies enclosed) and abide by the instructions issued by the Education Department from time to time.

5. The existing land should immediately be recorded in the name of the school.

6. The school shall have a duly constituted Managing Committee.

7. Conditions of the existing school building require to be further improved.

8. The school shall make a Reserved fund of at least Rs. 1,000/- (Rupees one thousand) and keep the same in Postal Savings Bank Account/ State Bank Accounts in the name of the school which shall be operated jointly by the Secretary of the school and the Inspector of Schools concerned.

9. Accounts, records, registers etc. shall be maintained for Dargahat Christian Jr. High school and its attached primary section separately.

10. Primary section attached to Dargahat Christian Jr. High school (from classes I to V) shall be separate establishment.

11. No graduate/non-graduate teachers shall be retained/appointed in the primary section of the school.
